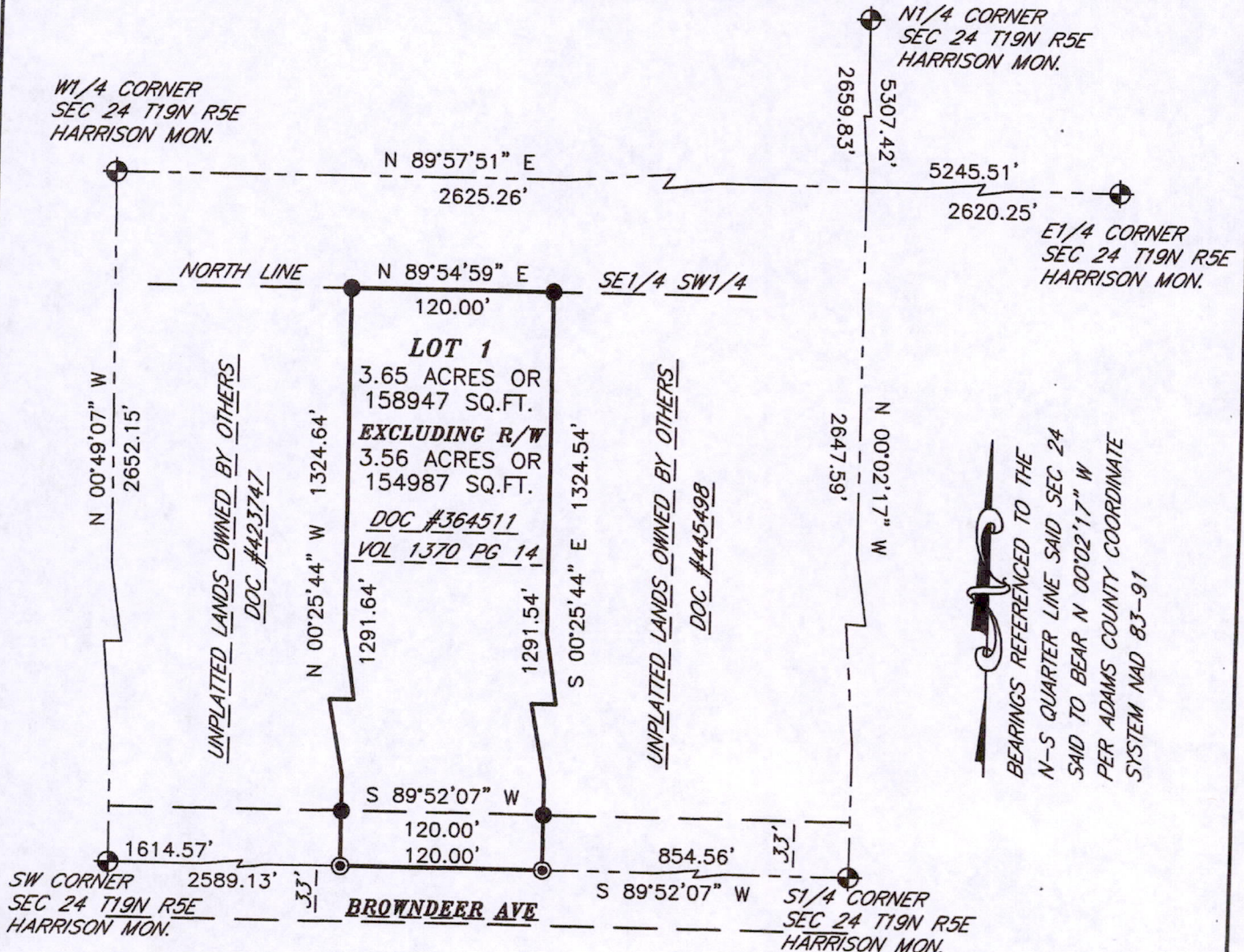


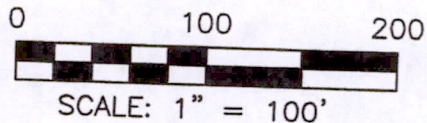


- ⊕ = GOVERNMENT CORNER LOCATION
