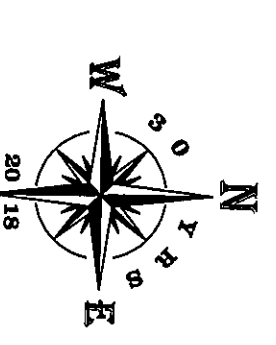


# PLAT OF SURVEY

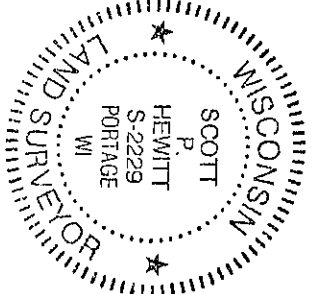
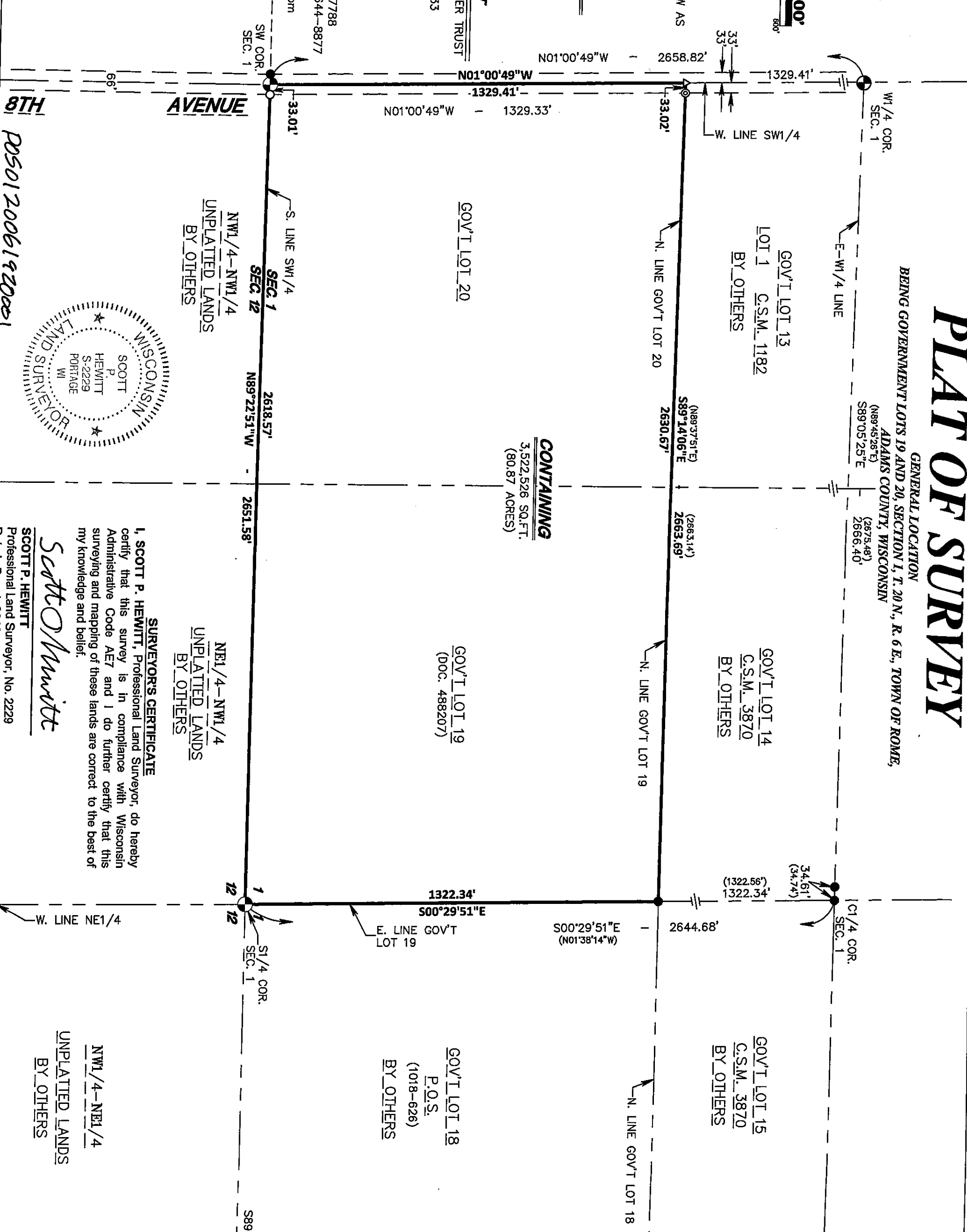
