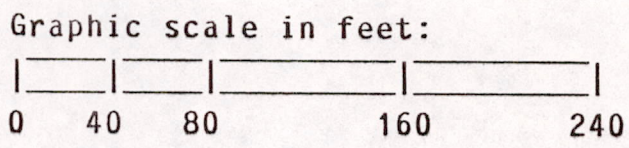
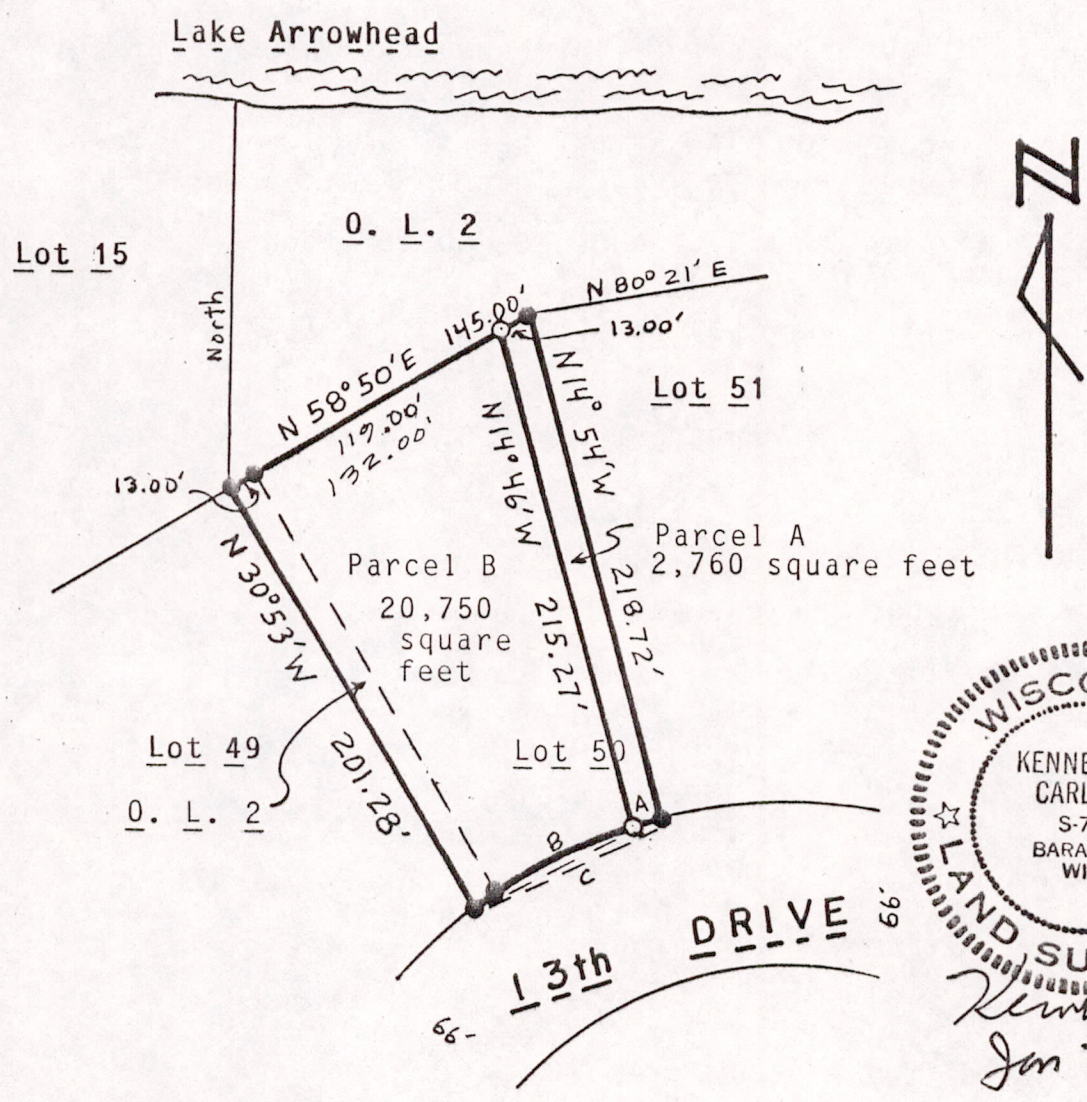

Parcel A - Description of new walkway (East Briar to POA)

A parcel of land located in part of Lot 50, Rain Dance Addition to Lake Arrowhead, Town of Rome, Adams County, Wisconsin bounded by the following described line: Beginning at the northeast corner of said Lot 50; thence S14°54'E, 218.72 feet; thence southwesterly on a curve to the left, radius 217.00 feet, whose chord bears S74°17'W, 13.00 feet; thence N14°46'W, 215.27 feet; thence N58°50'E, 13.00 feet to point of beginning.

Said parcel contains 2,760 square feet or 0.063 acres.

This parcel will have the same restrictions and covenants as Out Lot 2.

Parcel B - Description of area to be attached to owner of Lot 49 (East Briar to _____).

A parcel of land located in part of Out Lot 2 and part of Lot 50, Rain Dance Addition to Lake Arrowhead, Town of Rome, Adams County, Wisconsin bounded by the following described line: Commencing at the northeast corner of said Lot 50; thence S58°50'W, 13.00 feet to point of beginning; thence S14°46'E, 215.27 feet; thence southwesterly on a curve to the left, radius 217.00 feet, whose chord bears S62°58'W, 72.38 feet; thence N30°53'W, 201.28 feet; thence N58°50'E, 132.00 feet to point of beginning.

Said parcel contains 20,750 square feet or 0.476 acres.

This parcel will have same restrictions and covenants as Lot 50.
