


BASIS FOR MONUMENT LOCATION

1974 - PLS 1103 RAN EDM/TRANSIT TRAVERSE BETWEEN NORTHEAST AND NORTHWEST CORNERS OF SECTION 14, NO EVIDENCE AS TO THE LOCATION OF THE QUARTER CORNER WAS FOUND, THOUGH THERE EXISTS A PIPE AT A FENCE CORNER TOWARD THE NORTH, THERE IS NO EVIDENCE IN THE COUNTY SURVEYOR'S OFFICE AS TO THE ORIGIN OF THIS PIPE, ACCORDING TO SECTION 59.62 OF WISCONSIN STATUTES. THE QUARTER CORNER WAS CALCULATED EQUIDISTANT AND ON LINE BETWEEN THE NORTHEAST AND NORTHWEST SECTION CORNERS, SET A HARRISON MONUMENT AND TIED OUT.

2018 - PLS 2994 FOUND A HARRISON MONUMENT WITH A BROKEN-TOP 4" BELOW THE ROAD SURFACE AND 1 TIE. THE MONUMENT AGREES WITH THE EXISTING TIE. ACCEPTED THE HARRISON MONUMENT WITH A BROKEN-TOP AS THE CORNER LOCATION, SET 3 NEW TIES AND MEASURED TO THE TIES.
