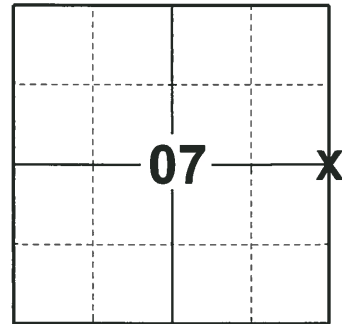

### BASIS FOR MONUMENT LOCATION

1974 - PLS 1103 FOUND A 1-1/4" IRON PIPE ALONG THE EAST RIGHT OF WAY OF 13TH AVENUE WITH SEARCH AREA. FOUND NO OTHER EVIDENCE OF THE CORNER OR ANY OF ITS ACCESSORIES. TRAVERSED THE EAST LINE OF SECTION 7. CALCULATED THE CORNER LOCATION EQUIDISTANT BETWEEN THE SOUTHEAST AND NORTHEAST AND 33.00 FEET WEST OF THE 1-1/4" IRON PIPE. SET A HARRISON MONUMENT AT THE CALCULATED LOCATION AND TIED OUT.

2018 - PLS 2675 FOUND A HARRISON MONUMENT 2" BELOW THE ROAD SURFACE, 1 TIE, 1 PROPERTY IRON AND 1 WITNESS. THE MONUMENT AGREES WITH THE EXISTING TIE AND WITNESS. ACCEPTED THE HARRISON MONUMENT AS THE CORNER LOCATION. SET 2 NEW TIES AND MEASURED TO THE TIES, PROPERTY IRON AND WITNESS.
