


BASIS FOR MONUMENT LOCATION

2015 - PLS 2452 FOUND A HARRISON MONUMENT WITH THE TOP BROKEN OFF 6"± BELOW THE GRADE OF A SAND/DIRT ROAD PER TIE SHEET BY WAYNE BASLER, DATED 6-15-81. FOUND THE ALUMINUM CAPPED WITNESS MONUMENT SOUTHEASTERLY OF THE HARRISON MONUMENT AND FOUND A %" ROD NORTHWEST OF THE HARRISON MONUMENT. ACCEPTED THE HARRISON MONUMENT AS THE CORNER, TIED INTO THE ALUMINUM WITNESS MONUMENT AND THE %" ROD AND PLACED 2 ADDITIONAL TIES. DATE OF FIELD SURVEY & MONUMENT RECOVERY WAS SEPTEMBER 02, 2015.

2018 - PLS 2994 FOUND A HARRISON MONUMENT 6" BELOW THE GROUND SURFACE AND 4 TIES. THE MONUMENT AGREES WITH 3 OF THE EXISTING TIES (THE SE TIE APPEARS TO BE DISTURBED). ACCEPTED THE HARRISON MONUMENT AS THE CORNER LOCATION. STRAIGHTENED THE SE TIE AND RE-MEASURED TO THE EXISTING TIES.



LOCATION (INDICATE CORNER BY "X")








I found a Harrison Monument $6"\pm$ below grade of a sand/dirt road per tie sheet by Wayne Basler, dated, 6-15-81. I found the aluminum capped witness monument southeasterly of the Harrison Monument and found a $\frac{3}{4}$ " Rod northwest of the Harrison Monument. I accepted the Harrison Monument (see picture), tied into the aluminum witness monument and $\frac{3}{4}$ " Rod, and placed two (2) ties all as referenced below. Date of field survey & monument recovery was September 02, 2015. Elevations provided on section corners are based upon the NAVD88 Datum.

(c) In the plan view drawing below, provide reference ties to at least 4 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron, or other equally durable material.) Describe witness monuments.
