


BASIS FOR MONUMENT LOCATION

2015 - PLS 2452 FOUND A HARRISON MONUMENT 3"± BELOW THE GRADE OF THE GRAVEL SHOULDER PER TIE SHEET BY ANTHONY B. KIEDROWSKI DATED, 11-1-79. HE ALSO FOUND THE ¾" IRON ROD NORTHEASTERLY OF THE HARRISON MONUMENT AND THE ¾" IRON ROD SOUTHEASTERLY OF THE HARRISON MONUMENT. ACCEPTED THE HARRISON MONUMENT, AND PLACE 2 ADDITIONAL TIES. DATE OF FIELD SURVEY & MONUMENT RECOVERY WAS **SEPTEMBER 02, 2015.**

2018 - PLS 2994 FOUND A HARRISON MONUMENT 6" BELOW THE SURFACE AND 4 TIES. THE MONUMENT AGREES WITH THE EXISTING TIES. ACCEPTED THE HARRISON MONUMENT AS THE CORNER LOCATION AND RE-MEASURED TO THE EXISTING TIES.



NOTE: THE CORNER FALLS 13'± NORTH OF THE CENTERLINE OF BADGER AVE











I also found the $\frac{3}{4}"$ Iron Rod northeasterly of the Harrison Monument and the $\frac{3}{4}"$ Iron Rod southeasterly of the Harrison Monument. I accepted the Harrison Monument (see picture), and placed two (2) ties all as referenced below. Date of field survey & monument recovery was September 02, 2015. Elevations provided on section corners are based upon the NAVD88 Datum.


