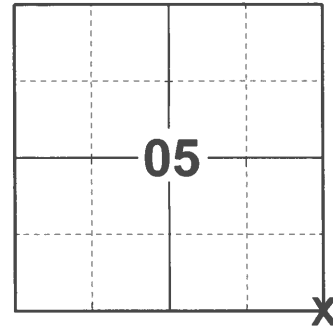

1975 - PLS 922 FOUND RAILROAD SPIKE SET BY DEAN JESSE IN PRIOR SURVEY AND MONUMENTED SAME. CHECKED COUNTY SURVEY RECORDS FOR RESURVEYS AND NONE WERE ON FILE. FIT TAPED AND TRANSIT TRAVERSE OF SECTION GOOD.

2020 - PLS 2675 FOUND A PK NAIL IN THE ROAD SURFACE, REMOVED IT, AND FOUND A HARRISON 6" BELOW THE ROAD SURFACE. FOUND 1 WITNESS DISTURBED. ACCEPTED THE HARRISON AS THE CORNER LOCATION. SET 4 NEW TIES AND MEASURED TO THE FOUND WITNESS.

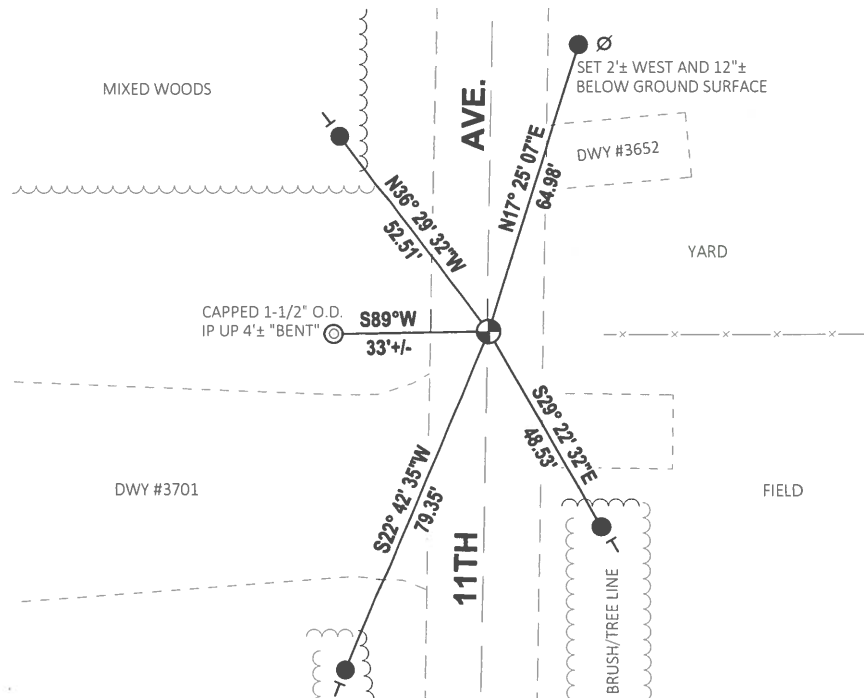

On July 13, 1993 the Harrison monument at this corner as set by Frederic W. Zietlow (Survey Monument Record dated July 31, 1975) was found. One of the tie points set on November 1, 1990 by JG and SS as shown on an update of the Survey Monument Record mentioned above was also found. Additional tie points were set as shown below.
