


BASIS FOR MONUMENT LOCATION

1977 - PLS 1103 RAN EDM/T2 TRAVERSE AROUND SECTION 18-16-6 AND TO THE SOUTHEAST CORNER OF SECTION 12-16-5. THE WEST QUARTER CORNER OF 18-16-6 (ALSO THE EAST QUARTER CORNER OF 13-16-6) HAD BEEN PREVIOUSLY MONUMENTED BY DON PAULSON ON 7-26-1974, BUT SINCE THE SOUTHEAST CORNER OF SECTION 12 WAS PLACED IN IT'S PRESENT LOCATION, IT BECAME NECESSARY TO CHANGE THIS CORNER TOO. 1977 TIE SHEET REFLECTS THAT CHANGE, WITH THE CORNER BEING MONUMENTED BY SINGLE PROPORTIONATE MEASURE ON LINE BETWEEN ADJACENT CORNERS. COULD NOT FIND ANY EVIDENCE OF THE ORIGINAL CORNER. SET A HARRISON MONUMENT AND TIED OUT.

2017 - PLS 2994 FOUND A HARRISON MONUMENT WITH A BROKEN-TOP 6" BELOW THE GROUND SURFACE AND 1 TIE. THE MONUMENT AGREES WITH THE EXISTING TIE. ACCEPTED THE HARRISON MONUMENT AS THE CORNER LOCATION. SET 3 NEW TIES AND MEASURED TO THE TIES.
