



FOUND 2" CAPPED PIPE WITHIN SEARCH AREA AT EAST QUARTER CORNER, BUT COULD FIND NO EVIDENCE OF THE ORIGINAL CORNER OR ANY BEARING TREES. UNABLE TO FIND ANY RECORD OF PLACEMENT OF THIS PIPE, BUT IT IS CONSISTENT WITH THE OTHER FOUND AT VARIOUS GOVERNMENT CORNERS IN SECTION 5, AS WELL AS SECTION 6. 




