


#### BASIS FOR MONUMENT LOCATION

1976 - PLS 1103 RAN EDM/T2 TRAVERSE AROUND SECTIONS 28 AND 29, AND PORTIONS OF ADJOINING SECTIONS TO DETERMINE SEARCH AREAS. EXCAVATIONS WITH BACKHOE YIELD NO EVIDENCE OF THE ORIGINAL CORNER OR ANY REMONUMENTATION, COULD FIND NO EVIDENCE OF BEARING TREES. RE-ESTABLISHED CORNER BY SINGLE PROPORTIONATE MEASURES ON LINE BETWEEN ADJACENT SECTION CORNERS. SET STANDARD HARRISON 11-4-76.

2020 - PLS 2675 FOUND HARRISON (BROKEN-TOP) 12'± BELOW THE ROAD SURFACE AND 2 TIES. THE CORNER DOES NOT AGREE WITH BOTH TIES. VERIFIED CORNER TO BE ON A NEAR STRAIGHT LINE AND EQUIDISTANT BETWEEN THE SE AND SW CORNERS OF SECTION 20. ACCEPTED THE HARRISON (BROKEN-TOP) AS THE BEST EVIDENCE OF THE CORNER LOCATION. SET 2 NEW TIES AND MEASURED TO THE EXISTING TIES.


